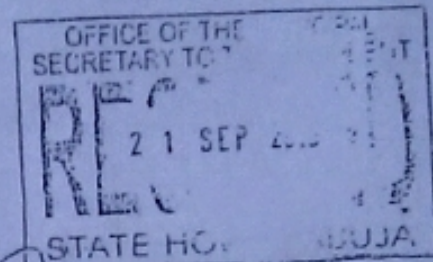

REQUEST FOR INTERVENTION FUND FOR THE NIGERIA POLICE FORCE FROM THE CENTRAL BANK OF NIGERIA

The purpose of this letter is to seek for Your Excellency's approval for the Central Bank of Nigeria Governor to provide an intervention fund to enable the Nigeria Police Force acquire 4Nos. Bell Armoured Helicopter, 40,000 Units of Motorola Hand held Radio Communication Equipment, 60Nos. Armoured Patrol Van and assorted Anti-Riot equipment for the maintenance of internal security, as the nation moves towards the period of intensive political and electioneering activities and providing a conducive operational environment for financial institutions.

Your Excellency, I wish to recall the immense support of financial institutions to the operation of the Nigeria Police Force through the coordinated effort of the Central Bank of Nigeria, especially the provision in 2007 of Armoured Personnel Carriers through the Bankers' Committee. The gesture had in no small measure assisted the Force to combat armed brigand attacks on banks and Bullion Vans that was hitherto the bane of the day.

As the nation moves towards a period of intense political and electioneering activities, resurgence of crime may once again become rampant and the financial institution may be a major target. This, therefore, necessitates the need to adequately position the NPF to meet this daunting challenge. In consideration of this, we are again constrained to seek for a kind intervention for the provision of some additional equipment listed below which are critical to the operations of the NPF.




